R18-098: AUTHORIZING THE NEW CASTLE COUNTY EXECUTIVE TO EXECUTE A GUARANTEE AGREEMENT FOR THE CONSTRUCTION OF AN INDOOR TENNIS FACILITY AT DELCASTLE PARK. Introduced by: Mr. Smiley

**FISCAL NOTE:** This Resolution authorizes the County Executive to execute the Guarantee Agreement necessary to allow Classic Tennis to borrow approximately \$2.86M to construct an indoor tennis facility on a portion of Delcastle Park. This resolution has no discernible fiscal impact.

R18-099: AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE A FINANCING AGREEMENT WITH THE DELAWARE WATER POLLUTION CONTROL REVOLVING FUND, ACTING BY AND THROUGH THE DELAWARE DEPARTMENT OF NATURAL RESOURCES AND ENVIRONMENTAL CONTROL, IN AN AMOUNT NOT TO EXCEED \$1,703,000, TO FUND THE CONSTRUCTION OF IMPROVEMENTS TO SEWER CAPACITY IN THE AREA JUST SOUTH OF NEWARK; PROVIDING FOR THE PURCHASE OF THE BOND; AND AUTHORIZING THE EXECUTION OF VARIOUS DOCUMENTS IN CONNECTION THEREWITH. Introduced by: Ms. Diller, Mr. Tackett

**FISCAL NOTE:** This Resolution pledges the full faith, credit and taxing power of the County to the prompt payment of the principal of, premium, if any, and the interest on the Bond.

### III. ORDINANCES:

<u>°18-062:</u> TO AMEND *NEW CASTLE COUNTY CODE* CHAPTER 14 ("FINANCE AND TAXATION") REGARDING THE RECOUPMENT OF COLLECTION FEES FOR DELINQUENT TAXES AND SEWER SERVICE CHARGES. Introduced by: Ms. Diller

**FISCAL NOTE:** By substantially increasing the County's ability to take delinquent vacant properties to sheriff's sale through the monition process, this ordinance, if adopted, is projected to increase General Fund revenues by approximately \$450,000 annually beginning in Fiscal Year 2019. (The Fiscal Year 2019 Recommended Budget presented to County Council includes the revenue effects of this legislation.) The costs and fees set forth in the ordinance are intended to recoup the costs borne by the County and not to generate revenue.

<u>°18-063:</u> AMEND THE GRANTS BUDGET: APPROPRIATE FUNDING FROM NEW CASTLE COUNTY COUNCIL TO THE COMMUNITY OUTREACH PROGRAM GRANT, WHICH IS ADMINISTERED BY THE DEPARTMENT OF COMMUNITY SERVICES Introduced by: Mr. Street

FISCAL NOTE: This Ordinance, if approved, will amend the Grants Budget by appropriating \$11,000 in funding to the Community Outreach Program Grant, which is administered by the Department of Community Services. Partial funding for this program will be provided from the County Council - Grants and Fixed Charges Budget Line Item in the FY20 18 Approved Operating Budget. The Community Outreach Program targets underserved areas within New Castle County working with the community members to make positive change by engaging youth, enhancing existing programs, establishing new relationships and creating new initiatives. The fiscal impact of this Ordinance, if approved, will be an increase in the authorized spending authority of the Grants Budget by \$11,000. This increase will affect FY2018 and beyond since this program is ongoing, without an expiration date, until all funds have been expended.

<u>°18-064:</u> AMEND THE FY2018 APPROVED OPERATING BUDGET: REDUCE THE GRANTS AND FIXED CHARGES BUDGET LINE ITEM OF COUNTY COUNCIL TO PROVIDE FUNDING FOR THE COMMUNITY OUTREACH PROGRAM. Introduced by: Mr. Street

**FISCAL NOTE:** This Ordinance, if approved, will amend the FY2018 Approved Operating Budget by reducing the County Council -Grants and Fixed Charges Budget Line Item by \$11,000 and transferring those funds to the Community Outreach Program. There will be no net fiscal impact if this Ordinance and its companion Ordinance are approved. The resulting effect will be the transfer of \$11,000 of FY2018 Approved Operating Budget spending authority to the Grants Budget. There is no fiscal impact beyond FY20 18.

<u>°18-065:</u> AMEND THE GRANTS BUDGET: APPROPRIATE \$164,300 IN ANTICIPATED STATE OF DELAWARE GRANT-IN-AID FUNDS TO THE ABSALOM JONES SENIOR CENTER FY2019, WHICH WILL BE ADMINISTERED BY THE DEPARTMENT OF COMMUNITY SERVICES. Introduced by: Mr. Hollins, Ms. Diller

**FISCAL NOTE:** This Ordinance, if approved, will amend the Grants Budget by appropriating \$164,300 in anticipated State of Delaware Grant-In-Aid funds to the Absalom Jones Senior Center FY2019 for the period July 1, 2018 through June 30,2019, which will be administered by the Department of Community Services. The Absalom Jones Senior Center provides a variety of services for the elderly in the surrounding community including: transportation to the center, adult programs, activities and social services. The fiscal impact of this Ordinance, if approved, would be an increase in the authorized spending authority of the Grants Budget. This increase will affect FY20 19 since the targeted program completion date for this grant is June 30, 2019. There is no fiscal impact anticipated beyond FY2019. FY2018 funding was authorized in the amount of\$164,300.

<u>°18-066:</u> AMEND THE GRANTS BUDGET: APPROPRIATE \$200,125.54 IN ACTUAL PROGRAM INCOME TO THE HOME INVESTMENT PARTNERSHIP PROGRAM (HOME) FY2015 GRANT TO BE ADMINISTERED BY THE NEW CASTLE COUNTY DEPARTMENT OF COMMUNITY SERVICES. Introduced by: Mr. Hollins, Ms. Diller

**FISCAL NOTE:** This Ordinance, if approved, will amend the Grants Budget by appropriating \$200,125.54 in actual program income to the Home Investment Partnership (HOME) FY2015 Grant, for housing rehabilitation, acquisition and administration of the program. Families served are in low to moderate income level in New Castle County- outside of Wilmington or Newark. This program is administered by the New Castle County Department of Community Services. The fiscal impact of this Ordinance, if approved, will be an increase in the authorized spending authority of the Grants Budget by \$200,125.54. This increase will affect FY2018 through FY2023 since the targeted program completion date for this grant is September 30, 2022.
