


Fiscal Year 2020 Recommended Budget Presentation to County Council

ETHICS

FY2020 ORGANIZATIONAL CHART



MISSION: The New Castle County Ethics Commission is created by the New Castle County Code and is responsible for administering and enforcing the Code's ethics and conduct provisions. The Commission's duties include advisory opinions, conducting preliminary inquiries, formal investigations and evidentiary hearings concerning alleged Code violations and imposing sanctions, if appropriate, as well as the financial interests disclosure process.

Ethics: The Ethics Commission conducts its meetings in accordance with the Delaware Code 29 Del. C10001-10005. The Delaware Code applies to a public body when it is engaged in a legislative or advisory function. The code does not apply to the Ethics Commission when it meets to consider a complaint or a request for an advisory opinion, waiver, or personnel issues because consideration of these matters is an executive function under the code. Therefore, although the commission may provide public notice of a meeting, the meeting itself may not be subject to the code. Even when the commission is engaged in a function subject to the code, the commission may conduct all or part of that meeting in closed session as permitted under Title 29.

ACCOMPLISHMENTS AND GOALS


The Ethics Commission has completed and/or is anticipated to complete the following accomplishments in Fiscal Year 2019.

- The Commission held 11 regular public meetings in 2018, including an annual public hearing in November 2018.
- By December 2018, the Commission received 6 sworn complaints since January 2018.
- The Commission processed 12 Advisory Opinion requests and responded to an increased number over last year of verbal or informal opinion or advice requests.
- The Annual Report was issued on February 1, 2019.
- All required Statement of Financial Interests forms were filed electronically.

The Ethics Commission will achieve the following major goals in Fiscal Year 2020.

- Notices to annual Statement of Financial Interests filers mailed by March 31, 2020.
- Investigation of all complaints performed per statutory requirements.
- Issue written responses to formal Advisory Opinion and Post-Employment waiver requests per statutory requirement.
- Annual Report issued by February 1, 2020.
- Completion of training on Ethics Code to all County employees and officials, new and current, on an annual basis in cooperation with the County Council and the County Administration.





The Ethics Office has one Part-Time position.


